Reservations: Reservations are accepted on a first-come, first-served basis and are valid for a 3 month (league-length) period of time. Renewals are accepted on a month-to-month basis thereafter, in accordance with adjacent policies with the Los Alamitos Unified School District and the Seal Beach Recreation and Community Services Department policies.

Priority Usage:

City sponsored events and/or programs > Non-profit; City service organizations > Resident Activities > Non-resident Activities > Commercial use.

Pool Use/Lifeguard: To qualify for use of the pool renter must provide lifeguards certified by American Red Cross, USA Swimming or another qualified lifeguard instruction provider. The Marina Safety Chief must approve prior to use. For questions about the pool please contact the Lifeguard Department Directly.
