New Donut Shop Opens at 207 Main Street

A new donut shop was approved on the second floor of 207 Main Street. The business is named "Baked in LA" because all baking takes place in a Los Angeles based bakery and is delivered for sale on Main Street every morning. The business opened the week of April 9th.



Coffee and Tea Coming to 350 Main Street

A new coffee and tea shop was approved on the first floor of 350 Main Street in Suite A, the former location of Doc's Pie Shop. The new coffee and tea shop is "Seventh Coffee and Tea," which is a partner to Portola Coffee Roasters. The business license will be issued soon and the shop is expected to open shortly thereafter.



Concrete Sidewalk Replacement

Sidewalk replacements took place in College Park East last week. Crews notify residents near the worksite and work with residents to ensure a smooth project. Sprinklers and parking are always a concern, and Public Works closely assists those who are impacted. Shown below, crews are working to clean the street near the site as the fresh concrete is curing. Clean up takes place over a two day period, and grass and parkways are always restored to prior conditions.



Paving Projects Underway

Small asphalt and paving projects have been taking place this past week. Shown below, pavement is grinded and replaced over a section of bad roadway on Seal Beach Boulevard. This section of the road was impacted from a recent waterline break, and this particular job lasted approximately five hours. Traffic control was maintained over the duration and grinded asphalt was hauled back to the asphalt plant for recycling.



Pets Need Protection, Too!

Take steps now to protect ALL members of your family, including your pets. Their safety is in your hands.

Step 1: Arrange a safe haven

Not all Red Cross shelters accept pets, so determine now where they'll need to go if you have to evacuate.

DON'T LEAVE PETS BEHIND! If it isn't safe for you it isn't safe for them.

- Contact your local veterinarian for a list of boarding kennels.
- Check local animal shelters to see if they provide foster care or emergency shelter.
- Identify pet friendly hotels/motels in your area.
- Identify friends or relatives near your home and outside your area who would be willing to take in your pets if necessary.
- Designate a permanent care giver who will adopt your pet if something happens to you. Choose someone your pet is comfortable with and who has successfully cared for animals in the past.

Step 2: Store emergency supplies

Put together a PET DISASTER KIT that's clearly labeled and easy to carry. Kit items to consider include the following:

- Food and water (minimum 3-7 days; 1 gallon of water per pet per day); feeding dishes
- Pet medications (2-weeks supply) stored in waterproof container; first-aid kit/manual
- Pet care information, including medical conditions, feeding instructions, behavior issues, and veterinarian contact information.
- Copies of medical records and license documents
- Recent photos of you with your pet (for identification if you are separated)
- Extra collars or harness and extra leash
- Crate or sturdy carrier (one per pet)
- Blankets and towels for bedding
- Litter box, litter, or crate liners
- Disposable garbage bags

PARTICIPANT CRITERIA:

- Must be **60** years of age or older
- **ELIGIBLE RESIDENTS:** Costa Mesa, Cowan Heights, Cypress, Garden Grove, Fountain Valley, Huntington Beach, La Palma, Lemon Heights, Los Alamitos, Midway City, Rossmoor, Santa Ana, Seal Beach, Stanton, Surfside, Tustin, Tustin Heights and Westminster.

SERVICE CRITERIA:

- **ENROLLMENT:** Return a completed application package to obtain your I.D. #.
- **SCHEDULING:** Rides must be scheduled a minimum of 5 business days in advance. Calling 5 business days in advance **does not guarantee** an appointment. Call to schedule your trip as soon as possible. Abrazar is required to prioritize trips when we are at capacity.
- **MILEAGE LIMIT:** 15 miles within OC & 10 miles outside of OC.
- **TRIP LIMIT:** 16 one-way trips per month. Exceptions based on medical treatment.
- **TRIP FEE:** \$2.00 per one-way trip. Waiver available and ability to pay does not affect eligibility.
