Adopt the Amended and Restated 2017/2018 Comprehensive Fee Resolution

At the June 12, 2017 City Council meeting a public hearing was held to adopt Resolution No. 6743 establishing new fees and charges for goods, services, and facilities provided by the City and amending and restating the 2017/2018 Comprehensive Fee Resolution. The Resolution passed with a 5-0 vote.

SoCal Edison Offers a New Incentive for EV Drivers

Southern California Edison is offering a \$450 reward to customers who drive all electric or plug-in hybrid vehicles. The incentive, which is being offered through SVE's Clean Fuel Rewards Program, applies to new, used and leased vehicles. Unlike most rebate programs, second and third owners of a vehicle are also eligible for the payment.

To qualify for a payment, customers need an active SCE residential account and a scanned copy of the car's registration that reflects the SCE account address. They simply submit an application through the <u>Clean Fuel Rewards</u> website. Once approved, Clean Fuel Rewards checks are mailed to the customer.



Save the Date! Public Information Meeting

The Orange County Transportation Authority (OCTA) and Caltrans have initiated an Improvement Project to enhance safety, smooth traffic flow, and improve pedestrian and bicycle pathways through the I-605/Katella Avenue interchange. The project is in the preliminary engineering and environmental review stage to identify potential significant environmental effects and ways to avoid or significantly reduce those effects.

On June 29, OCTA will host a public information meeting at the Los Alamitos Community Center on 10911 Oak Street, from 6:00-8:00 p.m. The meeting is to inform businesses, residents and local organizations about the project and the environmental review process. There will be information tables with staff members available to answer questions.

Fumigation of the Mary Wilson Library and Senior Center



Through effective planning and scheduling, Public Works managed the fumigation of the Mary Wilson Library and Senior Center this past week. Working with Community Services, the County of Orange Library Services, various utility companies (Southern Cali-

fornia Gas), and pest control, the fumigation was successfully started and finished with minimal impact to the community and library patrons. Work started Friday morning, fumigation occurred over the weekend, and clearance was given before the business day Monday, June 12, 2017. Due to the complexity of the building occupancy, County Inspectors were available to give clearance when acceptable conditions were present. Through careful planning and scheduling, this project was a success for Public Works, and the community.

Public Works Prepares for Summer Activities



The Public Works Beach Division has been busy preparing for summer activities at the beach. Crews installed two volleyball nets outside the 10th Street parking lot; every year, these nets are installed and maintained by the Beach Division, with special attention on the sand grooming near the courts throughout the summer. Crews also towed in the Junior Lifeguard storage containers under the Pier. Storage containers are specially graded and placed; they are fitted between the pilings of the Pier to keep from obstructing views and allow beach patrons the most space available.

The proposed LA Fitness was initially scheduled for a public hearing before the Planning Commission on Monday, June 19, 2017. Unfortunately, due to an inadvertent error in the noticing of the public hearing location, staff will be recommending the Commission open the item and continue the item to a special meeting on Tuesday, June 27, 2017 at 7:00 p.m. in the City Hall Council Chambers. This item is being recommended by staff to be continued to prevent any confusion as to the location of the public hearing for this item.

The Planning Commission will hold its regularly scheduled meeting on June 19, 2017 at 7:00 p.m. in the City Hall Council Chambers. A presentation on the LA Fitness project will not be given at this meeting but, staff will recommend the Planning Commission to open the public hearing to allow testimony for those who may not be able to attend the special meeting on June 27, 2017. The public hearing would remain open until the June 27th meeting. Please be aware that speakers are only allowed to address the Planning Commission once during a public hearing so anyone who speaks on June 19th would not be able to speak again at the June 27th meeting.

Water Department Activates MWD Import Feed

The Water Department activated its MWD import feed at Springdale and Westminster Ave. We will be taking a set flow of 5 CFS and pumping Lampson Well as needed in auto to meet the water demands of Seal Beach. In this process of importing MET water, we must bring down the water level of the Navy reservoir down below 5 feet so we can have a blend of the 2 different sources of water to prevent nitrification between chloramines and chlorine.

Seal Beach PD Open House

This past Saturday, June 10th, the Seal Beach Police Department hosted an Open House Event. This was an opportunity for the public to tour our station, meet police personnel, view historical displays, and get to know our Department better. It is estimated that 1,500 people attended the event. Some of the public presentations included the Long Beach Police Department Helicopter landing in the parking lot, tours of SWAT and Mobile Command Post Vehicles, a SWAT demonstration, and a K-9 demonstration.
