THE CITY OF SEAL BEACH IS REVIEWING WATER AND WASTEWATER RATES

Community Invited to Learn About City Water and Sewer Services and How Customer

Rates Are Determined

SEAL BEACH, CA- The City of Seal Beach is hosting a webinar on November 30 for residents to learn about their water and wastewater (sewer) services along with the status of rates studies the City began earlier this year. Water and sewer rate studies are financial reviews to project future revenues and expenses, usually for the upcoming five years. The ultimate purpose of each rate study is to determine whether operating revenues are sufficient to meet expenses for operations and maintenance, upcoming or needed replacements, critical capital improvements, and debt service.

Ideally, rate studies should be performed every 3-5 years. The City's last water and sewer rate study was in 2019 and adopted in early 2021. Financial consultants and City staff have been working diligently on a series of steps involving data evaluation and technical analyses to derive customer rates while considering customer impacts of any rate modifications.

Per state law, revenues generated from water and sewer service rates must only be used to fund the actual costs to operate and maintain the system including infrastructure projects and the cost of debt to finance capital improvement projects. Through the Water and Wastewater Enterprise Funds – separate from the City's General Fund – customer rates fund the complex water and wastewater systems. The cost of providing these essential services has increased due to inflation and rising costs of operations, maintenance, and environmental and regulatory compliance.

Webinar attendees will hear an overview of the City's water and sewer operations, revenue and infrastructure needs, and how the City is reinvesting revenues received from customer rates. The community is highly encouraged to attend the Zoom webinar to learn more and provide input into the rate study.
